

# IEPPV Membership Classifications 2010

---

## Membership Classification

### A. Professional Active (\$120, Premium \$190)

An individual primarily and actively engaged in the field of professional photography or videography who conforms to applicable laws as pertains to a business establishment, or one who is employed in a professional photographic capacity. In addition, the applicant must provide to the Board of Directors a showing of a body of work indicating the applicant's ability as a professional.

IEPPV is offering a **Professional Active Premium** upgrade. This is merely an "upgrade" to the Professional Active member and includes all classes, seminars and workshops that IEPPV offers, as space is available. No "Open House discount" is offered for this upgrade.

### B. Associate Active (\$75)

An individual employed by a Professional Active member in good standing, with membership privileges as directed by the Board of Directors.

### C. Affiliate Active (\$60)

An individual member of another PPC affiliate, with membership privileges as directed by the Board of Directors.

### D. Aspiring (\$150)

An individual who aspires to become a professional photographer. An aspiring member has limited membership privileges and responsibilities as directed by the Board of Directors. Each individual may be an aspiring member for no more than two years in their lifetime. The total number of aspiring members cannot exceed a percentage of total members of IEPPV as directed by the Board of Directors.

### E. Vendor Partner (\$200)

A manufacturer or firm providing photographic equipment, materials, laboratories, publishers, supplies or services to photographers (listed by company name). This classification includes an ad in each of IEPPV's monthly bulletins and on our website, and has limited membership privileges as directed by the Board of Directors.

#### **F. Student (\$75)**

An individual who is enrolled in a degree-granting educational institution, who presents evidence of such in the form of student ID or registration receipt.

#### **G. Honorary (no charge)**

An IEPPV Professional Active member in good standing, who has performed outstanding service to IEPPV and is nominated by two (2) board members and receives a three fourths (3/4) vote of all members of the Board of Directors. The duration an individual will be an Honorary Member shall be determined for each individual by the Board of Directors when nominated. Honorary members will have the same privileges as Professional Active members.

#### **H. Honorary Life Member (no charge)**

All presidents elected for two (2) consecutive full terms, in good standing of IEPPV, will be nominated for Honorary Life Member at the end of their last full term in office and must receive a three fourths (3/4) vote of all members of the Board of Directors. Honorary Life Members will have the same privileges as Professional Active members.

#### **I. Retired Member (\$60)**

An individual who has been an IEPPV Professional Active member in good standing for the preceding five years, is at least 65 years of age, and has retired, may be designated by the Board of Directors as a Retired Member. Retired Members will have the same privileges as Professional Active Members.
